____I UNDERSTAND AND AM AWARE THAT SNOW TUBING IS A HAZARDOUS ACTIVITY. I understand that snow tubing and the use of snow tubes involves a risk of injury to any and all parts of my body. I hereby freely and expressly assume and accept responsibility for any and all risks of injury and death while participating in this activity. I understand and am aware that the snow tube furnished could be HAZARDOUS to my well being while snow tubing. I also understand and agree that it is important to my safety to pay attention while loading, riding and unloading lifts, and I agree that I will not attempt to load, ride or unload a lift unless familiar with the proper way to do so. I understand I must observe all verbal and posted warnings or instructions and I must keep off closed lanes and out of closed areas.

____I agree that if any portion of this agreement is determined to be unenforceable by a court of law, all other parts of the agreement shall remain in full force and effect. I further agree that any claim I may bring against BMBW, Inc. shall be filed in the State of Ohio and I further agree that only the laws of the State of Ohio shall apply in the construction or application of this agreement.
